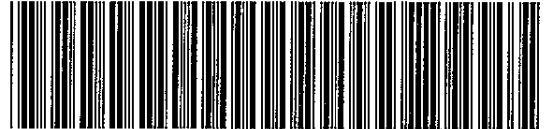

## ARTICLES OF ORGANIZATION

### Articles of Organization of ROUSSELLE PROPERTIES, LLC.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act (the "Act"), does hereby make, acknowledge and file the following Articles of Organization:

#### ARTICLE I

##### *NAME*

The name of the organization shall be ROUSSELLE PROPERTIES, LLC. (the "Company"). The principal office and mailing address is 1436 Bretta Street, Jacksonville, Fl. 32211.

#### ARTICLE II

##### *EXISTENCE*

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Secretary of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization, the Operating Agreement, or under the Act.

#### ARTICLE III

##### *REGISTERED OFFICE AND AGENT*

The name and street address of the registered agent and the registered office of the Company in the State of Florida is **ELAINE LUCAS, EQSUIRE, 900 Cesery Boulevard, Suite 118**, Jacksonville, Florida, 32211.

#### ARTICLE IV

##### *CAPITAL CONTRIBUTIONS*

The members of the Company shall contribute to the capital of the Company in the amounts agreed by the members.

**ARTICLE V**  
***MEMBERS; ADMISSION OF NEW MEMBERS***

The names and addresses of the members of the Company are as follows:

No additional members shall be admitted to the Company except with the written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless the transferee is approved to be a member.

**ARTICLE VI**  
***TERMINATION OF EXISTENCE***

The Company shall be dissolved upon the greater of a Member Majority Vote or a Majority in Interest (as those terms are defined in the Operating Agreement.)

**ARTICLE VII**  
***MANAGEMENT***

The Company shall be managed by its designated manager or managers, who shall be elected by the majority vote of the members. For all elections by manager(s), each member shall be entitled to vote in person or by proxy, in accordance with the Operating Agreement adopted by the members, which may contain provisions not inconsistent with the laws of this state or the Articles. Each member shall have a number of votes (including fractions) equal to such member's Units in the Company, with the total number of votes of all members totaling One Hundred (100). 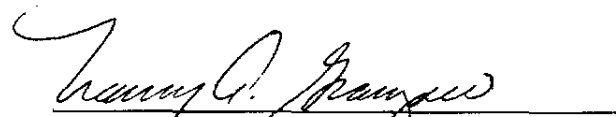
