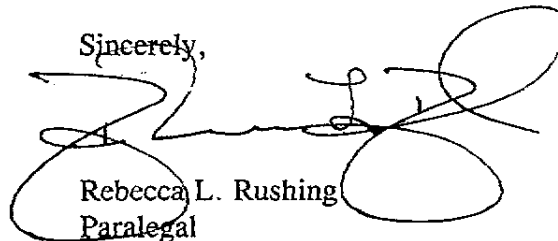

**ARTICLE I  
Name**
