**ARTICLES OF ORGANIZATION  
OF  
LAKE GUM PROPERTY, LLC**

The undersigned, acting as organizers of this limited liability company pursuant to Chapter 608 of the Florida Statutes, hereby form a limited liability company under the laws of the State of Florida and adopt the following Articles of Organization for such limited liability company:

**ARTICLE I - NAME OF COMPANY**

The name of the limited liability company is Lake Gum Property, LLC (the "Company").

**ARTICLE II - PRINCIPAL OFFICE**

The street address, and the mailing address, of the principal office of the Company is 9259 Pointe Cypress Drive, Orlando, Florida 32836.

**ARTICLE III - REGISTERED AGENT AND REGISTERED OFFICE**

The street address of the initial registered office of the Company in the State of Florida is 9259 Pointe Cypress Drive, Orlando, Florida 32836. The name of the registered agent of the Company at that address is James L. Gissy.

**ARTICLE IV - MANAGEMENT**

The Company is to be a member-managed company. However, the Company shall have two classes of membership interests: Class A voting membership interests and Class B non-voting membership interests. Only members who hold Class A voting membership interests shall have the right to vote on management decisions; holders of Class B non-voting

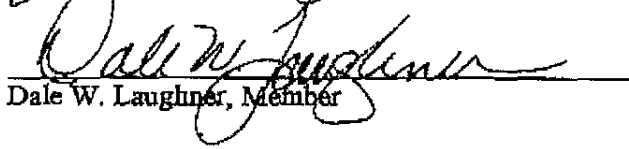
#### ARTICLE V - EFFECTIVE DATE
