ARTICLES OF ORGANIZATION

The undersigned natural person, who is licensed and otherwise legally authorized.

The undersigned natural person, who is licensed and otherwise legally authorized. to practice mental health counseling in the State of Florida, for the purpose of forming a ' limited liability company in accordance with the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I
