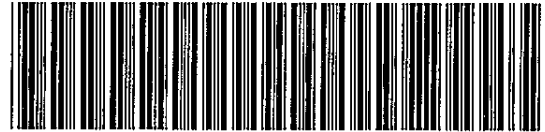

CONTINUING EXISTENCE


