ARTICLE I. NAME

ARTICLE II. ADDRESS

ARTICLE III. DURATION

The period of duration for the Company shall be perpetual unless the Company is earlier dissolved in accordance with either the provisions of the Florida Limited Liability Company Act, Sections 608.401 through 608.514 of the Florida Statutes Annotated (the "Act") or the Company's Operating Agreement among the members (the "Operating Agreement").

ARTICLE IV. MANAGEMENT

The Limited Liability Company is to be managed by a manager.

ARTICLE V. PURPOSE

The purpose for which the Company is being organized is to acquire and develop, for the purposes of lease or resale, residential and/or commercial real property, and to transact any other lawful business approved by the members of the Company and for which a limited liability company may be formed under the laws of the State of Florida.
