ARTICLES OF ORGANIZATION

OF

UTOPIA COURT INVESTMENTS, LLC

SEGRETARY OF STATE BRYISLON OF CORPORATIONS

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, adopts the following Articles of Organization:

ARTICLE I
