This Company is organized with general business purposes, has all powers provided by law and may use those powers to any lawful purpose.

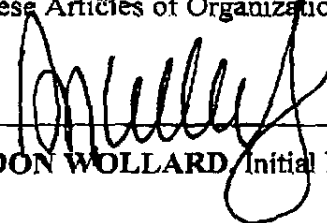
**ARTICLE V

The undersigned Incorporator has executed these Articles of Organization on this 5 day of October, 2005.

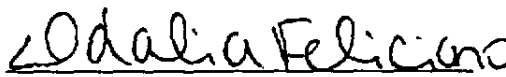

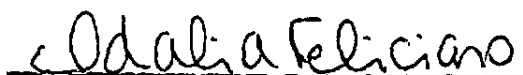
