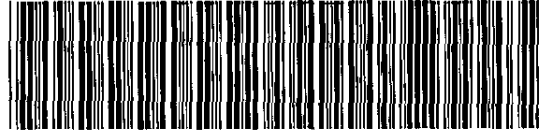

**ARTICLES OF ORGANIZATION

THE UNDERSIGNED hereby certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE I
NAME**

The name of the limited liability company (the "Company") shall be **Pilger- Biscayne Holdings LLC**

**ARTICLE II
ADDRESS**

**ARTICLE III
PURPOSES**

DURATION**

**ARTICLE V
REGISTERED AGENT AND OFFICE**

**ARTICLE VI
MANAGEMENT**

The Company is to be managed by a manager or managers and the name(s) and addresses of such initial manager is: William D. Pilger Sr. , 2500 County Barn Road, Naples Florida 34112

**ARTICLE VII
ADMISSION OF NEW MEMBERS**

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of the contribution by new members at the time the new members are admitted.


**ARTICLE VIII
