ARTICLE 4 - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the State of Florida is William R. Merkle, 1901 South Congress Avenue, Suite 120, Boynton Beach, Florida 33426.

ARTICLE 5 - CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company the cash and property set forth in Exhibit "A".

ARTICLE 6 - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members, or as provided in the regulations.

ARTICLE 7 - ADMISSION OF NEW MEMBERS

Except as may be set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to

participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent. Any member, however, may transfer his or her interest to his or her revocable trust of which the member is Trustee and that has been established for estate planning purposes by such member.

ARTICLE 8 - MEMBERS'S RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death or bankruptcy of a member, or the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by unanimous vote of all remaining members.

ARTICLE 9 - MANAGEMENT

The company shall be managed by its members in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these Articles of Organization.

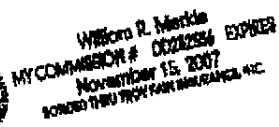
