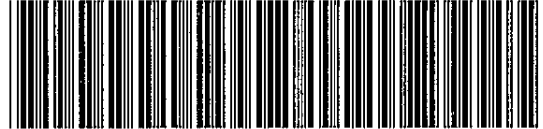

Management


