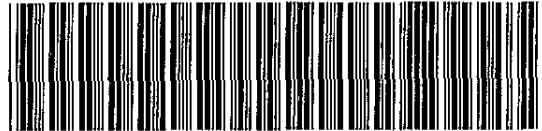

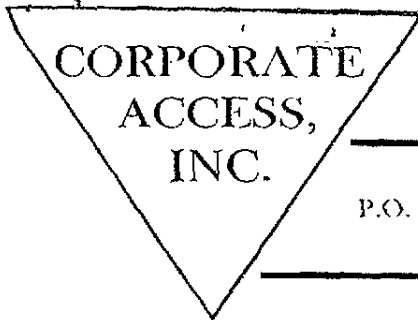

PREAMBLE; FORMATION

All notices to the Members pursuant to these Articles shall be in writing and shall be deemed effective when given by personal delivery or by certified mail, return receipt requested.


ARTICLE VI.




