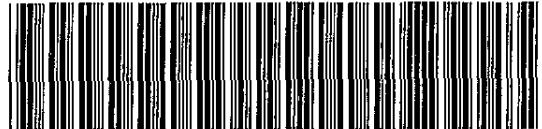

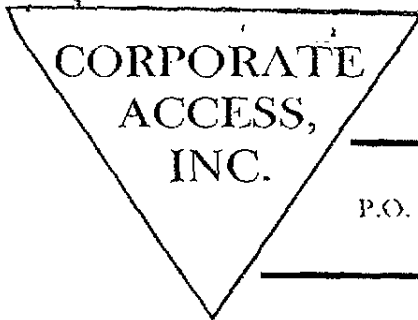

PREAMBLE; FORMATION

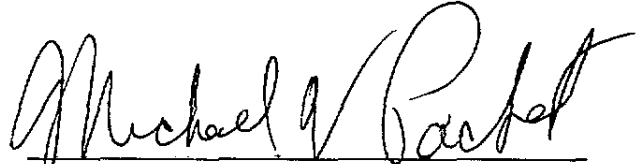

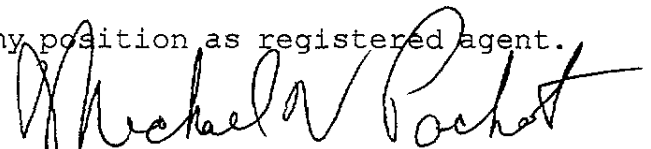
