**MANAGEMENT**

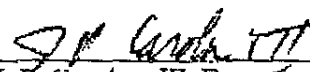
The Company shall be managed by one or more managers of the Company as provided in the Company's Operating Agreement. The initial manager of the Company shall be John B. Morgan.
