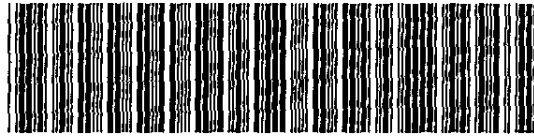



**Article II - Address**


