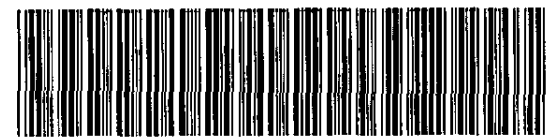

**Articles of Organization for K. EBERHARDT ARCHITECTURAL INTERIOR  
DESIGN CONSULTANTS, L.L.C.  
a Florida Limited Liability Company (FS 608.407)**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statutes Chapter 608, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

ARTICLE I – NAME

The name of this Company shall be K. EBERHARDT ARCHITECTURAL INTERIOR

ARTICLE II – PURPOSE

This Company is formed to operate an architectural design and remodeling business, and to provide all manner of services in connection therewith. ARTICLE IV – DURATION/CONTINUATION


ARTICLE VIII – INDEMNIFICATION
