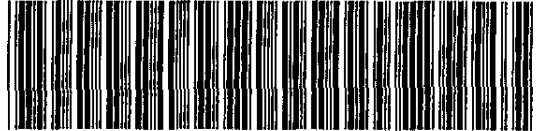

Pursuant to Section 608.411 of the Florida Limited Liability Company Act (the "Act"), Selah SeniorCare-Port St. Lucie, LLC, a Florida limited liability company (the "Company"), hereby submits these Articles of Amendment to the Articles of Organization of the Company:

FIRST: The name of the Company is SELAH SENIORCARE-PORT ST. LUCIE, LLC.
