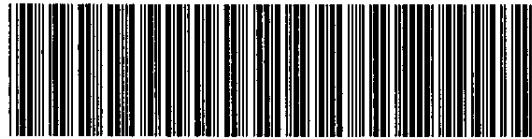

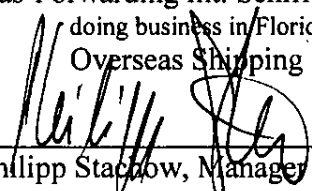
**Article I** of the Articles of Organization is deleted in its entirety and replaced by the following:

**The name of the Limited Liability Company is American Forwarding & Logistics, LLC.**

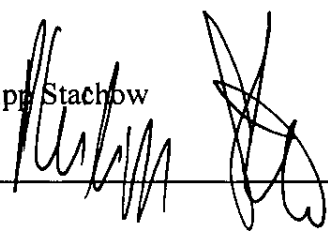
All other provisions of the original Articles of Organization shall remain in full force and effect as originally filed.
