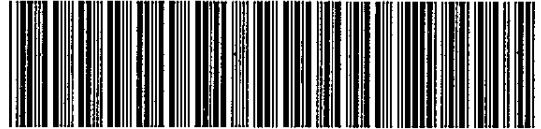

## ARTICLES OF ORGANIZATION

OF

### BLUE & BYERS, PLLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), and Chapter 621 of the Florida Statutes (the "Professional Service Corporation and Limited Liability Company Act") for the purpose of forming a Professional Limited Liability Company (within the meaning of Section 621.03(3), Florida Statutes) under the laws of the State of Florida do set forth the following:

1. NAME.

The name of the Limited Liability Company is BLUE & BYERS, PLLC (hereinafter referred to as the "Company").

2. PERIOD OF DURATION.

The period of duration of the Company shall be perpetual, unless it is dissolved as provided in the Florida Limited Liability Act or the written Operating Agreement to be executed by all of the Members of the Company.

3. PURPOSE.

The purpose for which the Company is organized is to engage in and carry on the practice of law in the State of Florida and in such other states as the Company and its attorneys be qualified to practice law, and all activities incident thereto. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of Chapters 608 and 621, Florida Statutes.
