ARTICLES OF ORGANIZATION OF FLORIDA FAMILY HOLDINGS, LLC

The undersigned, acting as organizer of Florida Family Holdings, LLC, under the Florida Limited Liability Company Act ("the Act"), adopts the following Articles of Organization for said limited liability company:

ARTICLE I NAME
