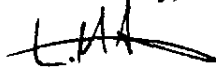

## ARTICLES OF ORGANIZATION

OF

RJV, LLC

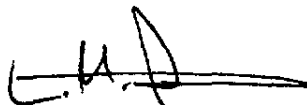
The Company is to be managed by one or more managers, appointed by the members in accordance with the terms of the Operating Agreement.
