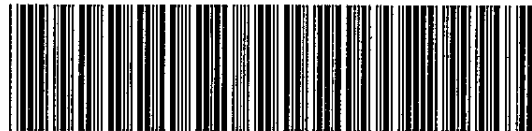



of

NAME




