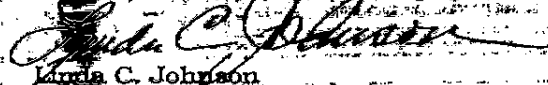

ARTICLES OF ORGANIZATION

SECLUSION BAY DEVELOPERS LLC
