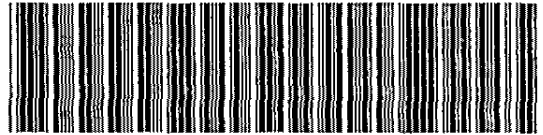

SECTION II - DATE OF FILING OF ARTICLES OF ORGANIZATION

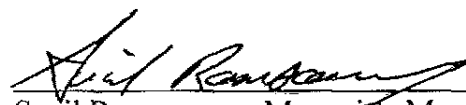
The Articles of Organization were filed on October 11, 2005, effective October 14, 2005.
