

ARTICLES OF ORGANIZATION LAND USE ASSOCIATES, LLC

SECRET S PA SHO The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file following Articles of Organization:

ARTICLE I - NAME

The name of the limited liability company shall be LAND USE ASSOCIATES, LLC, ("Company").

ARTICLE II - ADDRESS

The mailing address of the principal office of the Company is P. O. Box 1958, Tavares, Florida 32778. The street address of the Company is 225 W. Main Street, Tavares, Florida 32778.

ARTICLE III - DURATION
