**ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is **12211 DORSETT RD. JDJ MGMT, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company shall exist effective as of October 12, 2005 and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

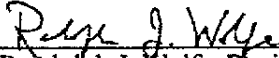
