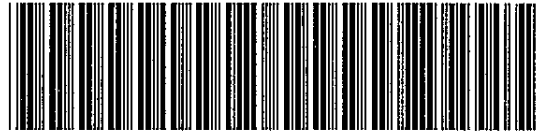

ARTICLE I — Name

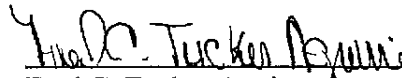
ARTICLE V — Admission of Additional Members

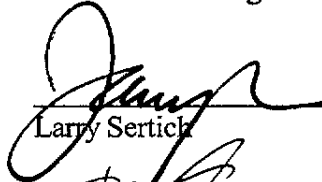
The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be as set forth in the Operating Agreement of the LLC.
