

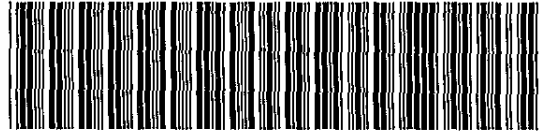

ARTICLE I - Name:

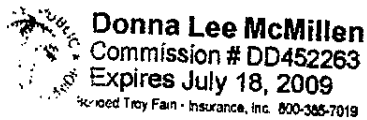
