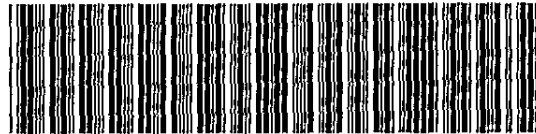

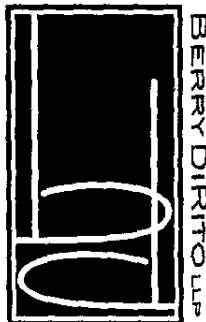

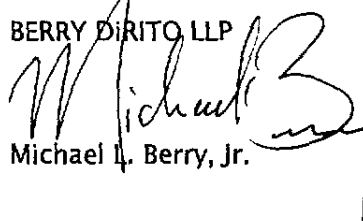

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby adopts the following Articles of Organization:

ARTICLE I

The name of the limited liability company is TriNova Group, LLC ("the Company").

ARTICLE II

The principal office and street mailing address of the Company will be located at 1061 Riverside Avenue, Suite 200, Jacksonville, FL 32204.

ARTICLE III

EFFECTIVE DATE
10-12-05

The Company shall have perpetual existence, commencing upon October 12, 2005, or such other date no more than five (5) days prior to the filing of these Articles of Organization with the Florida Department of State, whichever is later.

ARTICLE IV

The general purpose of the Company and the nature of the business to be transacted by the Company are to engage in any and all activities and exercise any and all powers, rights, and privileges for which a Company may now or hereinafter be organized under the laws of the State of Florida.

ARTICLE V

The street address of the initial registered office of this Company is 1 Independent Drive, Suite 1200, Jacksonville, FL 32202, and the name of the initial registered agent of this Company at that address is Thomas McDonald.

ARTICLE VI

Additional members may be admitted as provided in the Operating Agreement of the Company.

ARTICLE VII

The right, if given, of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the

Company will be as provided in the Operating Agreement of the Company.

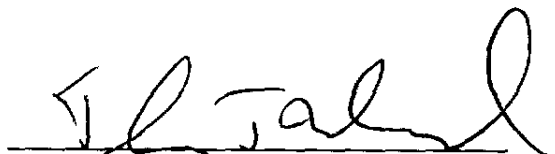
