**ARTICLES OF ORGANIZATION

The undersigned for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I  
NAME**

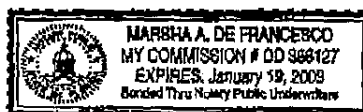
