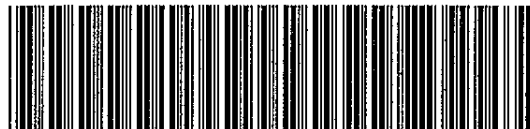

FIRST: The Articles of Organization were filed on October 11, 2005 and assigned document number L05000102354.


SECOND: This Amendment is submitted to amend the following:
