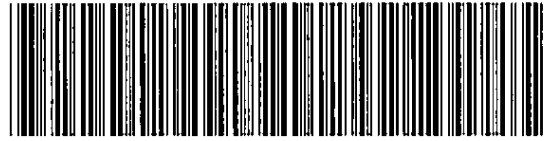



**ARTICLES OF MERGER

FIRST: The name, form/entity type and jurisdiction of formation of each of the merging parties are as follows:
