ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I - Name:

Upon either death or withdrawal of any member, the remaining members shall have the right to choose either to purchase the interest of the deceased or withdrawing member or to dissolve the company. In the event of an election to purchase the interest of a deceased or withdrawing member, the purchase price for said interest shall be paid and determined as documented in the Limited Liability Company Operating Agreement.

Article IX - Transferability of Interests:

No interest in the Company may be transferred except as specifically set forth in the Limited Liability Company Operating Agreement.

Article X - Amendments and Revisions:

The Articles of Organization may be modified, revised or amended if the modification(s), revision(s) or amendments are made in writing, signed by all members then in existence, and filed with the Secretary of State of the State of Florida according to law.


