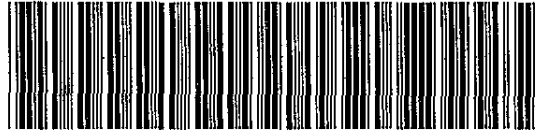

The undersigned organizer adopts the following Articles of Organization for the Limited Liability Company named below pursuant to the Limited Liability Company Act of the State of Florida.

ARTICLE I – NAME

The name of the Limited Liability Company is Coastal Smart Construction, L.C.

ARTICLE II – MAILING ADDRESS

ARTICLE III – PERIOD OF EXISTENCE

The period of existence for Coastal Smart Construction, L.C. shall be perpetual from the date of filing these Articles with the Department of State, except for the limitation set forth in Florida Statutes Section 608.441.

ARTICLE IV – REGISTERED AGENT AND OFFICE

ARTICLE VI – TERMINATION OF MEMBERSHIP

If a member of the company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy or upon the occurrence of any other event that terminates the continued membership of a member in Coastal Smart Construction, L.C., the remaining members may, by unanimous written agreement, continue the business of Coastal Smart Construction, L.C.

ARTICLE VII – MANAGEMENT


The management of Coastal Smart Construction, L.C. is reserved to the members. The following person shall initially be the managing member:
