SECOND: The articles of organization were filed on October 19, 2005.

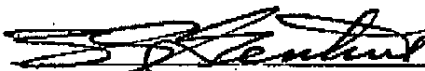
THIRD: The date dissolution was authorized was 1/8, 2007.

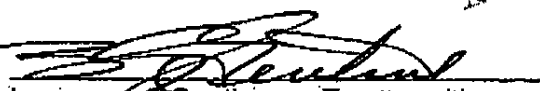
