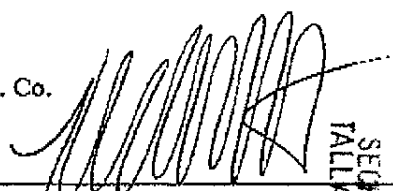
Pursuant to the provisions of Florida Statutes Section 608.415, C & P, LLC submits the following statement in designating the registered office/registered agent, in the State of Florida:
