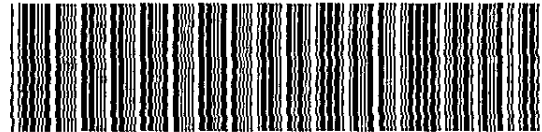

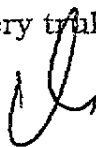

**ARTICLES OF ORGANIZATION**

The undersigned, acting as the organizers of this Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company:

**ARTICLE I - NAME**

The name of the limited liability company shall be **D&B HOLDINGS, L.L.C.** (the "Company").
