## ARTICLES OF ORGANIZATION OF



#### IDEAL PROCESSING, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be **IDEAL PROCESSING, LLC**, ("Company").

#### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 1320 Northwest 183rd Street, Miami, Florida 33168 and the mailing address shall be the same.
