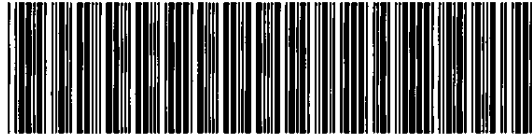



Second: The following amendment to the articles of organization was adopted by the limited liability company:


ARTICLE I - CORPORATE NAME

All other Articles contained in the Articles of Organization remain unchanged.


