

#### ARTICLES OF ORGANIZATION

OF

#### FLA SUNSHINE L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

### ARTICLE I

The name of the limited liability company shall be FLA SUNSHINE L.L.C. "Company". The principal place of business of the Company in Florida shall be 7727 B. Holiday Drive, Sarasota, FL 34231.

## ARTICLE II DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall terminate not later than December 31, 2010, unless the Company is earlier dissolved as provided in these Articles of Organization.

## ARTICLE III PURPOSES AND POWERS

The general purpose for which the Company is organized is to hold title to real property and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

# ARTICLE IV REGISTERED OFFICE AND AGENT

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.

# ARTICLE IX MANAGEMENT

The Company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 
