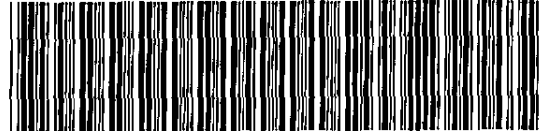

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be: SUNDANCE FARMS AIR PARK, LLC., a Florida Limited Liability Company.

ARTICLE II – ADDRESS

The mailing address for the principal office of the company is 23799 S.W. 167th Avenue, Homestead, Florida 33031.

ARTICLE III – DURATION

The company shall commence its existence on the date these Articles of Organization are filed of record by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization.

ARTICLE VII – ADMISSION OF NEW MEMBERS

ARTICLE VIII – MEMBERS RIGHT TO CONTINUE BUSINESS

The company shall be dissolved upon the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by unanimous vote of the remaining members.

ARTICLE IX – MANAGEMENT

The company shall be managed by its member in accordance with regulations adopted by the member for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these Articles of Organization. 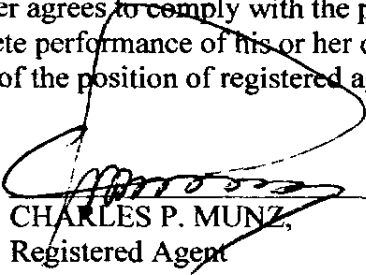
