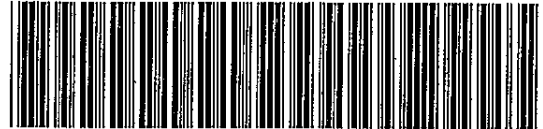

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the Limited Liability Company shall be SILVERWOOD MHP, LLC

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the company is 711 AVERY LANE, APOPKA, FLORIDA 32703.

ARTICLE III – DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified.
