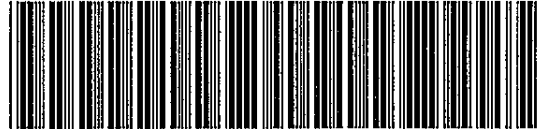

NAME




