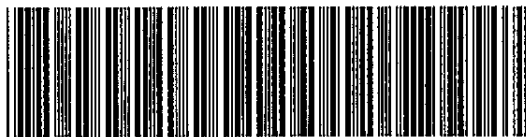



# ARTICLES OF ORGANIZATION

OF

1. **Name.** The name of the limited liability company is **Customized Hebrew Embroidery, LLC.**




