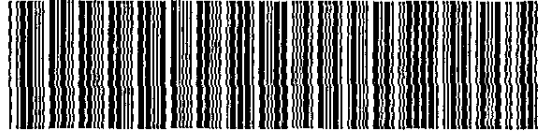

**Articles of Organization for EAST COAST LEAK DETECTORS, L.L.C.
a Florida Limited Liability Company (FS 608.407)**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statutes Chapter 608, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

ARTICLE I – NAME

The name of this Company shall be EAST COAST LEAK DETECTORS, L.L.C.

ARTICLE II – PURPOSE

This Company is formed to operate a swimming pool leak detection business, and to provide all manner of services in connection therewith. 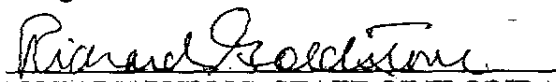

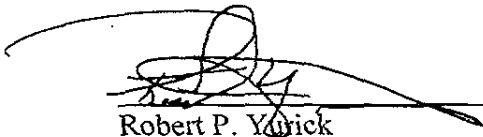

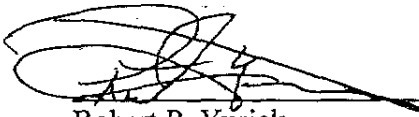
