

ARTICLES OF ORGANIZATION OF SHOOT OUT MOUNTAIN LOT, LLC

The undersigned, desiring to form a Limited Liability Company under and pursuant to §608.405, Florida Statutes, does hereby certify as follows:

FIRST: The name of said limited liability company shall be SHOOT OUT

MOUNTAIN LOT, LLC.

SECOND: SHOOT OUT MOUNTAIN LOT, LLC shall exist in perpetuity.

THIRD: Copies of the Operating Agreement of SHOOT OUT MOUNTAIN


