Upon the death of one member, that member's interest shall pass in accordance with the member's will or trust and the Company shall remain in existence.

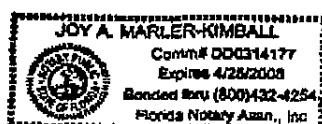

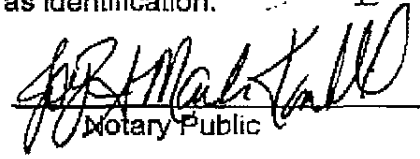

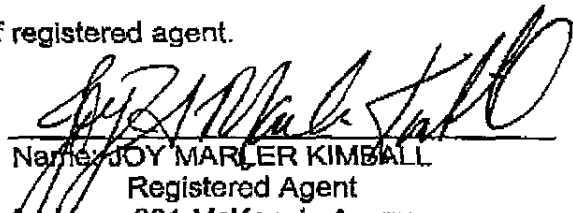
