ARTICLES OF ORGANIZATION
OF
SEA GATE LAND VENTURES I LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, does set forth the following:

ARTICLE I - NAME

The name of the Company is SEA GATE LAND VENTURES I, LLC.

ARTICLE II - DURATION

The duration of the Company is perpetual.

ARTICLE III - ADDRESS AND PLACE OF BUSINESS

ARTICLE IV - PURPOSE

The purposes of the Company shall be to own, improve, operate, lease, manage, construct, develop, convert to condominiums, purchase, sell (in parts or in one bulk sale transaction) mortgage or encumber real estate, either directly or indirectly, to lend money and guarantee the debt of others, to act as a general or limited partner in other entities, to make investments and own interest in other entities, any business related thereto or useful in connection therewith, and any other lawful business purpose or activity permitted by the Florida Limited Liability Company Act (the "Act"). The Company shall have all powers of a limited liability company as provided in the Act, including authorization to purchase, mortgage, encumber, sell, lease, manage, develop, convert to condominiums, construct, renovate, operate, improve, alter, transfer, joint venture or otherwise convey and encumber all or any portion of the Company's property at any time and from time to time, to lend money and guarantee the debt of others, to act as a general or limited partner in other entities, to make investments in and own interests in other entities, and to do all other things necessary or appropriate to carry out the foregoing purposes.

The Company shall indemnify each managing Member, manager and officer to the fullest extent permitted by the Florida Limited Liability Company Act.

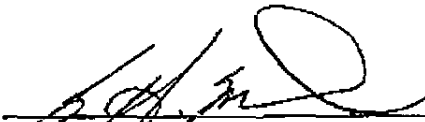
ARTICLE IX - COMMENCEMENT OF EXISTENCE
