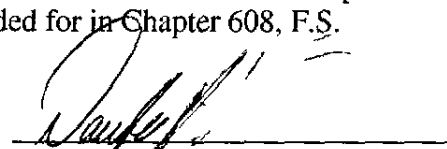

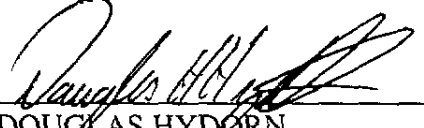
ARTICLE IX – CONTINUATION

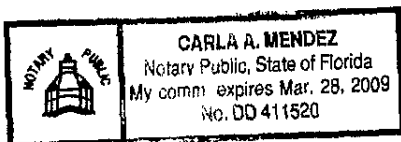
