1. Name. The name of this limited liability company is ALLSHELL CONSTRUCTION SERVICES, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, including to act as a construction subcontractor for various trades in residential and commercial construction, and to engage in business and such other lawful activities as are reasonably necessary, convenient or incidental to these purposes.

4. Place of Business. The mailing and street address of the Company's principal office is 2033 Trade Center Way, Naples, Florida 34109.

5. Registered Agent and Office. The name of the initial registered agent of the Company is Stanley V. Richards. The street address of the initial registered agent of the Company is 2033 Trade Center Way, Naples, Florida 34109.

6. Additional Members. Additional members to the Company may be admitted, but only upon the unanimous consent of all members of the Company at the time admission is sought, except interests may be given to another member.

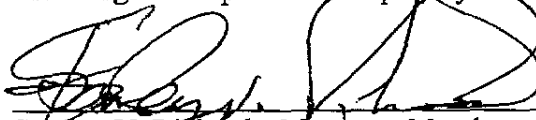

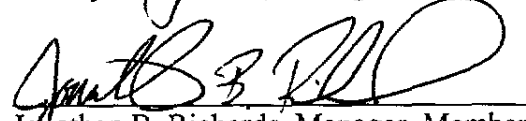
8. Voting. The Company is authorized to issue membership interests with voting rights and membership interests without voting rights.

10. Member's Rights. Pursuant to section 608.4235 of the Florida Statutes, no member of the Company other than a manager shall be an agent of the company solely by virtue of being a member, and no member other than a manager shall have authority to incur debt or contractual liability on behalf of the company solely by virtue of being a member. Any Operating Agreement of the company as defined in section 608.402(24) of the Florida Statutes must be in writing and signed by all the initial members.

The undersigned Managers and Members freely executed these Articles of Organization effective as of the 18 day of October, 2005, affirming under penalties of perjury that the facts herein are true.

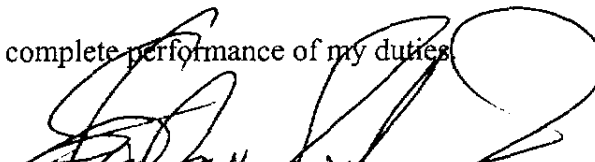
